- *Install a new server with firewall protection to upgrade internet reception*
- *Upgrade Comcast Broadband and install Verizon Broadband to improve internet connectivity for use of multiple devices for all students*
- *Purchase iPads, Chromebooks, and laptops to replace outdated tech, as well as charging and sync carts to store iPads and sync education applications for the students*
- *Purchase desk shields for student protection and sanitization equipment to clean and disinfect the school*
- *Purchase art, music, and gym equipment*

Consider giving through the EITC Tax Credit Program where you can direct your PA taxes to benefit Holy Innocents School.

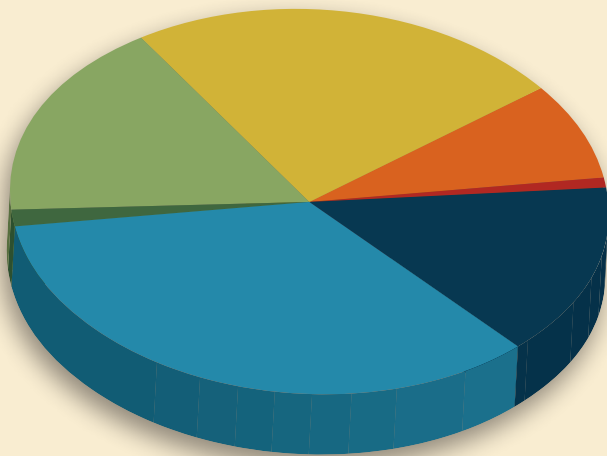
